25.2 From SHDC an invitation to attend a workshop regarding the Plymouth and South West Devon Joint Local Plan at 7.00 p.m. on Thursday 7 July at 7.00 p.m. in Quay House (see agenda item 16/28).

25.3 From SHDC a report and tender brief received by the Executive Committee meeting held on 16 June to appoint a consultant to produce a masterplan for allocated site K2 (Quayside, Kingsbridge). Members noted that the Kingsbridge & Salcombe Area Partnership (KSAP) had conducted much research and local consultation several years ago on this matter which had been reported within their community plan "Action 2020".

25.4 From SHDC minutes of the Development Management Committee held on 8 June for Refusal of planning application 28/1560/15/O (outline application with landscaping reserved for erection of 32 dwellings and vehicular access on part of allocated site K4, Garden Mill, Kingsbridge). Reasons for Refusal were:

- harm to the setting of a Grade II listed building (Buttville House),
- major development in the AONB would cause visual harm,
- incoherent design and layout, and
- insufficient level of affordable housing and other financial contributions would not be delivered.

It was **RESOLVED** to note the above planning decision and correspondence.

ANY FURTHER CURRENT PLANNING MATTERS

Further to agenda item 16/25.2, Members received information and maps relating to Kingsbridge from the Plymouth and South West Devon Joint Local Plan: Planning for Thriving Towns and Villages. A public consultation had begun on 1 July with a deadline for comments of 12 August. It was noted that the 6 allocated sites (K1 to K6) within the extant Kingsbridge Development Planning Document (February 2011) had been retained however, there were some changes to dwelling numbers, employment areas and allocation sites. Two new sites had been included: Fore Street Car Park and West of Belle Hill however, some potential sites suggested by KTC when consulted upon South Hams "Our Plan" had not been included. It was **RESOLVED** to hold an extraordinary full council meeting at 7.00 p.m. on Tuesday 2 August to consider the Plymouth and South West Devon Joint Local Plan and feedback to SHDC.
