### 15/52 ANY FURTHER CURRENT PLANNING MATTERS

- **52.1** Madeline's Restaurant, 15 Church Street, Kingsbridge, TQ7 1BT had applied for a new premises licence for the sale of alcohol for consumption on the premises Monday to Sunday from 12.00 p.m. to 9.30 p.m. KTC was not a statutory consultee for licensing applications but could forward comments to SHDC ward members. It was **RESOLVED** to make District Cllrs Gilbert and Wingate aware that alcohol was already being served on the premises and to request confirmation that extraction arrangements on site were in accordance with approvals for planning applications 28/0673/15/F and 28/1710/15/DIS.
- **52.2** Members queried water extraction from the Western Backway leat for an adjacent car washing business. The Town Clerk reported that this had been queried previously with the Environment Agency and was in order; he would forward the relevant email correspondence to committee members.
- **52.3** SHDC had provided a listing of outstanding planning enforcement cases for Kingsbridge dated 1 October 2015 which were currently under investigation. The information was confidential and was not for dissemination to the public or outside bodies. Members noted the alleged cases.
