**CARRY OUT SEWER REPAIRS**

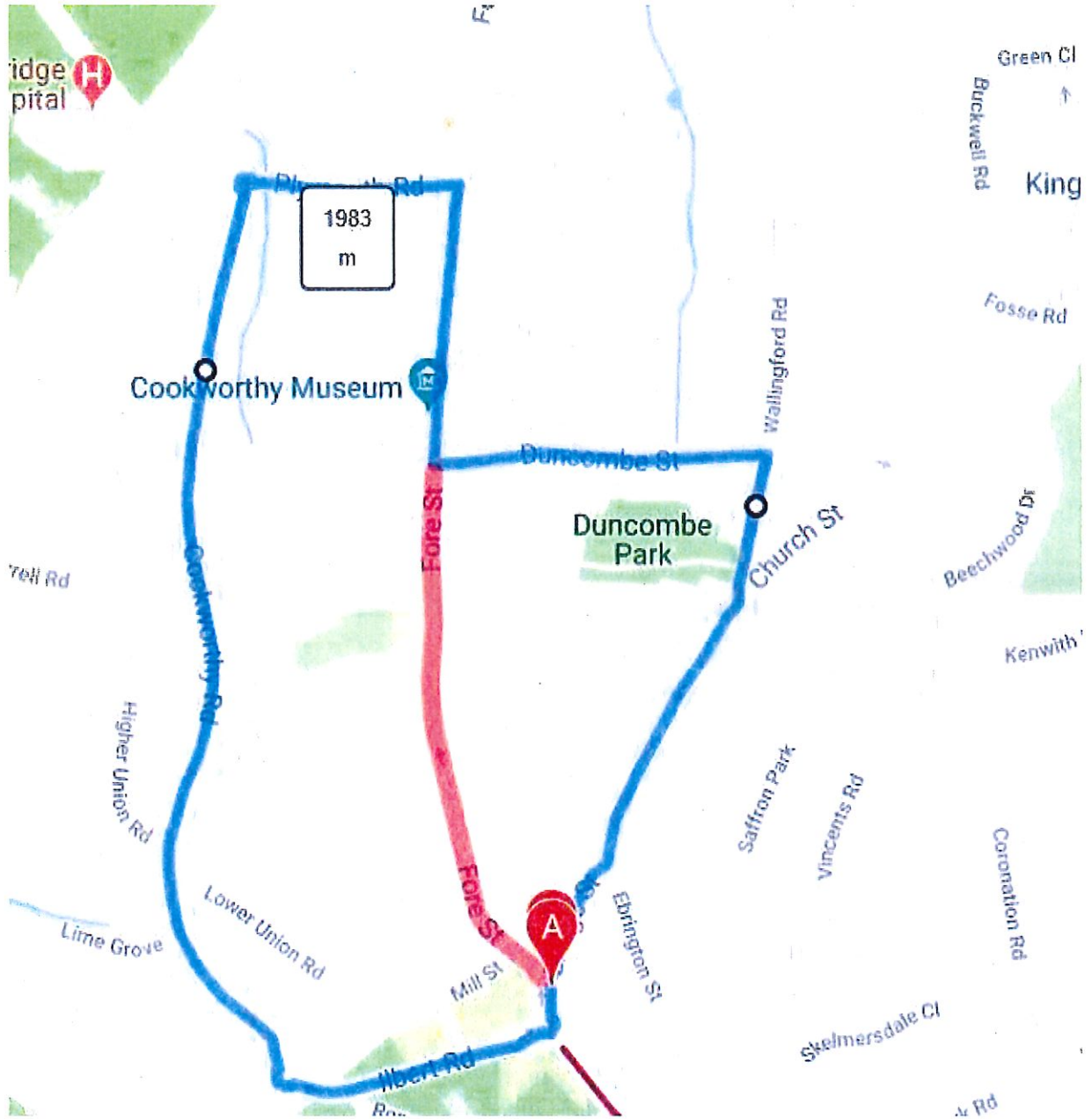
