## **Public Open Forum**

Crispin Jones briefed Members on planning application 3985/22/FUL to site 2 containers for a paddleboarding school in Quay Car Park:

- The proposal was for 2 in number containers of circa 15m<sup>2</sup> each to be sited on the eastern/estuary side of the car park which would take up 9 car parking spaces closest to the Slipway.
- The overall site area would be circa 120m<sup>2</sup>.
- He had already gained a licence for the school.
- The containers would not be permanent fixtures and could be moved.
- They would have wooden cladding including portholes and planters to make them presentable.
- The proposal would be a trial for a 2 year period until the end of 2024.
- The original suggestion had been for the school to be positioned towards the top of the Slipway itself on the western fringe however, South Hams District Council (SHDC) had responded that it could have interfered with boat owners.
- There was much local support for the paddleboarding school, it would be attractive and another amenity for the Kingsbridge community and visitors.
