22/86 APOLOGIES FOR ABSENCE

Apologies were received from Cllr Danielle Rawstron.

Public Open Forum

a. Richard Boyt asked if the Town Council (KTC) could request an update from South Hams District Council (SHDC) Development Management regarding planning application 1629/22/ARM for Reserved Matters of a 14 dwelling housing development at Dennings in Wallingford Road. Moreover, he queried why the application had been validated by SHDC after the expiry of the 3 year time limit from the outline approval. He had attempted to liaise with SHDC but had not received feedback to date.

Cllr Edmonds thanked Richard for his comments and reported that KTC would request an update from SHDC.

b. Julie Taylor distributed several photos of run-off from the K4/Lock's Hill development site off Derby Road which was entering the Dodbrooke stream and which subsequently discharged into the estuary. The run-off had mixed with building spoil from the site and was very dirty. She also distributed photos of the wall at the entrance to the Recreation Ground off Derby Road which had been badly damaged that afternoon with large pieces of rubble laying on the ground.

Cllr Edmonds thanked Julie for her comments and reported that SHDC and the Estuaries Officer had recently visited the site and would be very aware of the run-off from the site and potential environmental impacts. KTC would make SHDC aware of the damaged wall and forward her photos.

There was no statutory consultation for the above planning application which had been forwarded for information only

KTC: A previous application 2727/22/CLE for a Certificate of Lawful **Development was Refused by the Local Planning Authority on 28 November** 2022 on the grounds that works had been carried out in breach of Condition 6 (Tree Protection). The Condition Discharge Compliance Table submitted with the above proposals is incomplete as it does not include planning application 3874/22/ARC to discharge said Condition 6 which was Refused by the LPA on 13 December 2022. The applicant now appears to revert to a previous incarnation and approval of Condition 6 by the LPA. However, the crux of the recent Refusal of the revised Condition 6 was with regard to general tree protection measures and the retention of trees T5, T16, T17 and T18. The Arboricultural Method Statement now submitted at Appendix 2, paragraph 5.15, reports that "problems are foreseen" with trees T5, T16 and T18 notwithstanding that a previous application reported the trees as Health Class 1 and "the trees exhibit no significant structural risk features" and SHDC's Tree Specialist (report dated 1 December 2022) identifies that said Ash trees should be retained.

Recommend Refusal on the grounds that it is abundantly clear that there remains unresolved issues relating to the protection of trees T5, T16 and T18 and the applicant perceives them as an inconvenience to the development.

It was **RESOLVED** to note the above planning decisions and to forward the findings of the planning consultation at 88.4 above to SHDC Development Management.
